1. Call to order

The meeting was called to order at 9:01 a.m. by Chairman Carothers.

5. Consider approval of monthly financial reports.

A motion to approve the July & August 2023 financial reports was made by Andy James. The motion was seconded by Inez Faison. Motion carried unanimously.

6. Consider course of action concerning employee health benefits provided by Coryell CAD.

A discussion concerning the renewal rates provided by the Texas Health Benefits Pool (formerly TML Health) which is the district's current provider of employee health benefits occurred. The renewal rate for the current plan includes an increase in premium payments of over 50%. Texas Health Benefits Pool also included four (4) additional plan options with decreasing levels of coverage; however, the premium payments would remain in excess of 30% of the budgeted numbers on the most economical plan. No action on the renewal proposal was taken at this time.

7. Consider course of action concerning a bank depository contract extension for 2024-2025 of the Coryell CAD.

A motion to approve the extension of the 2022-2023 depository contract for the 2024-2025 depository contract term was made by Inez Faison. The motion was seconded by Andy James. Motion carried unanimously.

8. Consider course of action concerning contract extension with Capitol Appraisal Group for utility and industrial appraisal services to be provided to Coryell CAD.

A motion was made to authorize the Chief Appraiser to extend the contract with Capitol Appraisal Group by Andy James. The motion was seconded by Inez Faison. Motion carried unanimously.
